Any modifications to the CEC Application Form will result in your application not being accepted for processing. Further, your Application can be denied should there be any false declaration or fraudulent documents submitted.











#### Completing the CEC Application Form A and Covering Pre-screening Form


The CEC Application Form A which has been combined with the Pre-Screening Form (labelled as 'CEC Application Form) on the EMA's website, must be completed and submitted with all supporting documents to begin the CEC Process. The table below shows the different steps to completing the CEC Application Form.





Step 3: Completing the Cover Page of Form For individuals: The signature on the CEC Application Form A For Companies: The head of the organisation along with the MUST be that of the owner/operator of the proposed company stamp MUST be affixed development/facility







#### Step 4: Completing Section A of Form A

#### Please note:

The CEC Application Form A and the Pre-Screening Form MUST be completed in BLOCK LETTERS

#### For individuals –

The response to Question 1 of the CEC Application Form A: 'The name of the applicant' **MUST** be the name of the owner/operator and **NOT** agent/consultant, etc.

Completing the remainder of the Form A While all details of the proposed development may still be at a conceptual stage, the CEC Application Form A requires that the Applicant provides a description of the project's inputs, outputs, potential impacts and proposed mitigation measures from site preparation, through construction to its operational or post-construction phase.


#### Do not leave any questions blank.

If a question is not applicable to the proposed project, please state 'Not applicable' or 'N/A'. If the question is relevant to the project but the information is unknown state 'Uncertain'.

#### Responding to Question 9 of CEC Form A:

Please indicate all Designated Activities that may be applicable to your proposed project. The CEC (Designated Activities) Order provides a list of all Designated Activities. This document can also be found on the EMA's website.

## Step 6:

Additional documents required for completeness of CEC application

In the case of:	The following is required:
Where the Applicant is the property owner or leasee of the site:	Evidence of certified copies of Proof of Ownership (e.g. deed, license/lease agreement)
Where the Applicant is not the property owner	A signed authorisation letter from the property owner(s) giving the required approval to use said lands supported by proof of ownership and a copy of a valid form of the National Identification (front only) from the owner(s)
Agents acting on behalf of the Applicant (Individual or Company)	A signed authorisation letter required if you are acting on behalf of the Applicant for completing said application. This must be accompanied by a valid copy of identification (as identified above) from the Applicant AND person(s) authorised to act on their behalf
Where the Applicant is a company	Please provide a copy of the Certificate of Incorporation (Companies)
